Opening of Sealed Bids shall be on <u>June 28, 2021, 3:00 p.m.</u> live streamed via ZOOM. Meeting ID and Password shall be given to Bidders' representative/s upon submission of their sealed proposals/quotations. For convenience and ease in the conduct of proceedings, bidders or their authorized representatives must provide the PLLO BAC Secretariat, either via e-mail or any acceptable mode of electronic transmission, a copy of their authorization and company identification to participate in the said bidding.

4. General Conditions:

- 1. All proposals/quotations must be typewritten in the company's letterhead of the bidder.
- 2. PhilGEPS Registration Certificate, Business Permit, BIR Certificate of Registration, Income or Business Tax Return, Tax Clearance, and Omnibus Sworn Statement shall be attached upon submission of the quotation.
- 3. All proposals/quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.
- 4. Payment shall be prepared through Advice to Debit Account upon receipt of the suppliers Statement of Account, Delivery Receipt, Invoice, and subject to deduction of applicable taxes.

5. Payment

- 1. The supplier shall be paid in full upon certification from the PLLO to the effect that the Items have been duly delivered.
- 2. Late delivery shall be subject to penalty equivalent to 1/10 of 1% of the total cost of undelivered items.
- 6. The PLLO reserves the right to reject any or all bids, to waive any minor defects therein, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, and to accept only the offer that is most advantageous to the government, without incurring any liability from the affected bidder/s.
