3. Bidding will be conducted through open competitive bidding procedure using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

4. Bidding is restricted to Filipino citizens/sole proprietorships, partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138

5. A complete set of Bidding Documents may be acquired by interested Bidders from the Administrative and Financial Management Division (AFMD) (see address below) and upon payment of a non-refundable fee for the Bidding Documents and amounts pursuant to the Schedule.

The bidding documents may also be downloaded free of charge from the website of the PhilGEPS provided that Bidders shall pay the non-refundable price not later than the submission of their bids.

6. The PLLO will hold a Pre-Bid Conference on May 18, 2021; 2:00 PM at the PLLO-Malacañang for those who secured and paid bid documents.

Pursuant to the Presidential Proclamation on Enhanced Community Quarantine and STRICT implementation of social distancing due to the Covid 19 pandemic, the PLLO is equipped with a facility that used video conferencing facilities to continuously communicate and collaborate with stakeholders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 31 May 2021; 10:00 AM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bids shall be opened immediately thereafter at the PLLO 2/F New Executive Bldg., Malacañang, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. Bidders shall drop their duly accomplished eligibility requirements, technical and financial proposals in two separate sealed envelopes in the designated bid box located at the Bidding Room.
- 9. The PLLO reserves the right to reject any or all bids, to waive any minor defects therein, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, and to accept only the offer that is most advantageous to the government, without incurring any liability from the affected bidder/s.
